Acknowledgement of Risk Release of Liability

I AM AWARE THAT ROCK WALL CLIMBING INCLUDES CERTAIN RISKS, INCLUDING BUT NOT LIMITED TO THE RISK OF SERIOUS INJURY OR DEATH. I AM VOLUNTARILY PARTICIPATING IN THIS ACTIVITY WITH KNOWLEDGE OF THE DANGERS INVOLVED, AND HEREBY AGREE TO ACCEPT FULL RESPONSIBILITY FOR THE RISKS INVOLVED. _____(Initial)

In consideration of being allowed to use the rock climbing wall at the Jim Parsley Community Center (JPCC), I acknowledge and agree to the following:

Hazards of Climbing. Rock wall climbing is an inherently dangerous activity.

Climbing is Voluntary. The use of the JPCC rock wall, facilities, equipment or apparatus is voluntary with complete and full understanding that such usage involves hazards and dangers.

Conduct. I will obey and comply with all rules, regulations, or instructions of the Recreation Assistant in charge of the rock wall. I am responsible for conducting myself in a safe and reasonable manner. I will not use the rock wall while under the influence of drugs or alcohol, or while suffering from or experiencing any physical, mental or emotional condition that might impair me.

Personal Equipment. I am responsible for checking and maintaining the safety and good operating condition of my personal equipment, gear or apparel while using the rock wall.

Rental Equipment. Any equipment, gear or apparel that I may receive, rent or borrow from JPCC that I may use, I use at my own risk.

Waiver. I, and on behalf of my heirs, personal representatives and assigns, agree that we will not sue, or otherwise make any claim against JPCC, its respective officers, directors, employees and agents.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I AM VOLUNTARILY SIGNING THIS AGREEMENT.
